- Juan Human Service (HS) Hot Topics
  - Due Diligence training offered to County employees Let us know if you want a copy of the training, as a reference point
  - o Importance of contractor/subrecipient monitoring
    - 1. Risk assessments conducted yearly
    - 2. E&Rs version of the contractors general ledger. This services as back up when invoice is submitted
    - 3. Monthly contract meetings where issues are brought, solutions discussed, where issues are documented in case of notice to cure
    - 4. Site visits funding sources request these are taken place yearly
    - 5. Procurement/Program evals requested/required by funding sources and regulatory bodies
      - Working on OpenGov automation
    - 6. Invoice reviews important for back up documentation
    - 7. Contract cost close out we budget HS contracts by Fiscal Year (FY), and to be able to successfully close out a FY, this step needs to take place
    - 8. Review of single audit/audited financials helps ensure whatever is happening at contractor level, it's on par with County requirements. If there are a lot of findings and we're not aware, that wouldn't look good to the public, media, etc.

- Andy Alimohammadi (OCWR) SB 1383
  - o Keeping organics out of landfills (yard trimmings, leave, branches food scraps, etc)
    - 1. Helps reduce methane emissions (harmful gas to environment)
  - o No cost at our landfills to pick up compost and mulch (no qty limit either)
  - Revision to the EPP (Environmentally Preferable Purchase Policy) which is on alliance website
  - Move compost and mulch from our facilities to recycle to meet mandates
- SB 3130
  - o Gov. Code 26227.5
  - Post reports every quarter on any activity described therein
  - o Effective January 1, 2025

#### F. PROCUREMENT SYSTEMS

- OpenGov
  - Grant management went live 9/1/24
  - Asset management deploys December 2024
  - o OpenGov and Pavilion integrated so it's automatically uploaded to Pavilion
  - Procurated has also fully integrated with OpenGov, so now reminders for annual performance evaluations will be issued automatically from procurated through OpenGov
  - o Reminder that OpenGov has offer for Alliance (25% discount on their suites). Anaheim is taking advantage and currently implementing.
